Address After Wedding _____

1. This constitutes an order for wedding photographs, album(s) and prints. It is understood that any and all images and rights to those images remain the property of **Ed Ferguson Photography**. The parties agree that **Ed Ferguson Photography** may reproduce a judicious selection of such photographs as samples of our work to be shown to prospective clients, and for instructional and advertising purposes consistent with the highest standards of taste and judgment. Any reproduction of any image produced in connection with this agreement is prohibited without specific written consent of **Ed Ferguson Photography**.

2. While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding events, **Ed Ferguson Photography's** entire liability to Client for any breach of this agreement, claim, loss, or injury arising from **Ed Ferguson Photography's** performance is limited to a refund to Client of the deposit and any and all amount paid by Client for services.

3. It is understood that **Ed Ferguson Photography** will be the sole professional photographer employed for the wedding day, and will have priority over any other type of photographer or videographer employed in connection with the wedding in positioning of cameras and equipment. Any breach of this agreement may constitute a reason for non-completion of the job with no liability to **Ed Ferguson Photography** and loss of initial deposit by signing party.

4. Upon signature, **Ed Ferguson Photography** reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, all deposits are non-refundable, even if date is changed or wedding cancelled for any reason. However, if **Ed Ferguson Photography** is able to contract another wedding assignment the full sum of the deposit will be refunded.

5. Client selects _____ package. A \$500 deposit is due at signing of this contract, with the remaining balance to be paid in two equal payments. The first half is due one week prior to wedding and the second half is due upon completion of the proof book (generally 1-2 months following event).

All terms of this agreement are understood and agreed upon by both of the undersigned.

Silver: \$1,800 -- 2 Photographers/6 hours, 30-page album with prints, 8x10 Proof Book, DVD slide show of proofs, web site of proofs, engagement portrait session or \$50 print credit (may add CD with hi-resolution images for \$300)

Bronze: \$1,200 -- 2 Photographers/4 hours, 8x10 proof book or an extra hour of coverage, CD with hi-res images & web site of proofs
